EDAs that have not registered

The table below (based on the electoral districts as defined in the 2012 *House of Assembly Act*) lists, by electoral district and by party, the EDA registration status.

Party:

- Atlantica: Atlantica Party Association of Nova Scotia No EDA Registrations
- Green: Green Party of Nova Scotia No EDA registrations
- Liberal: Nova Scotia Liberal Party
- NDP: Nova Scotia New Democratic Party
- PC: The Progressive Conservative Association of Nova Scotia

Status:

- "Registered" indicates that the appropriate financial report and EDA registration form has been filed (Form 4 or Form 4-1) and accepted.
- "Not Registered" indicates that the appropriate EDA registration form has not been filed and accepted. Two EDA's requested deregistration in 2016.
- "Suspended" indicates that an EDA has not filed their financial reports for the previous calendar year.
