SECTION 180(4) OF THE ELECTION ACT STATES: AN APPLICATION FOR REGISTRATION PURSUANT TO THIS SECTION MUST BE ACCOMPANIED BY A COMPLETE AND ACCURATE PETITION IN THE PRESCRIBED FORM, SIGNED BY NO FEWER THAN TWENTY-FIVE ELECTORS IN EACH OF TEN DIFFERENT ELECTORAL DISTRICTS, REQUESTING REGISTRATION OF THE POLITICAL PARTY.

SIGNATORIES MAY BE CONTACTED BY THE CHIEF ELECTORAL OFFICER TO CONFIRM THEY ARE ELECTORS AS DEFINED IN THE ELECTIONS ACT.
